

To the Board of Directors CHENNAI FERROUS INDUSTRIES LIMITED

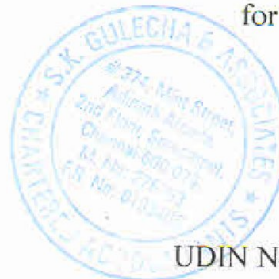
